# **Background**

No evaluation of SCIDA II, although several changes in the project deesign happened during implementation (SIMPI, EU Cofunding, COVID-19, etc.).

Discussions on SCIDA II in the consultations between IGAD and the BMZ in 2019 and in an online consultation in June 2021

Guidance on the design of the new project obtained from BMZ include e.g.

- More focussed approach, lean project design
- Stronger focus on cross-border issues also on local level
- Show the value-added of IGAD as service provider for cross-border issues

# **Project Strategy**

#### **Overall Goal:**

• Put clear focus on strengthening IDDRSI's capacities for cross-border cooperation (1) in the fields of NRM (2) and COVID-19 response (3).

#### Multi-level Approach:

- Regional level (Djibouti Secretariat): strengthen administrative and managerial processes; evaluate experiences in cross-border-cooperation; disseminate best practice.
- Local level: Pilot measures in the field of cross-border natural resource management for pastoral transhumant and agropastoral communities (water, pasture, livestock health, adaptation to climate change).

#### **Entry points:**

- Promote simplified standard procedures (ICT tools, SOPs, ..)
- Strengthening the role of CBDFU
- Strengthening of transnational steering committees
- Rely on an established system for real-time monitoring and surveillance for pandemic preparedness

### **Project Objectice**

IDDRSI's capacities for cross-border disaster risk management are strengthened at the regional and local levels



### **Output A**

Increased efficiency of the services of the IGAD Secretariat for the IGAD member states for crossborder natural disaster risk management and adaptation to climate change



### **Output B**

Measures to strengthen the resilience of local pastoral and agro-pastoral communities against natural disasters in the Karamoja Cluster cross-border area are piloted.



### **Output C**

A regional, transnational realtime monitoring and surveillance system for pandemic prevention and preparedness is available.

### Outcome (objective) Indicators (tentative)

- Number of proposals to adapt the administrative workflow for increasing the efficiency of the IGAD Secretariat as a service provider for its member states
- Number of decisions on cross-border natural resource management and adaptation to climate change in the Karamoja Cluster jointly taken by high level representatives of Kenya and Uganda and moderated by IGAD/IDDRSI
- Successful implementation of X gender-sensitive cross-border pilot measures in the fields of water and pasture management under the Cross-border Development Facilitation Unit (CBDFU) in the Karamoja Cluster
- Number of requests from IGAD member states for IDDRSI facilitation support for cross-border management of natural resources in various clusters
- Number of requests from IGAD member states for IDDRSI facilitation support for cross-border management of natural resources in various clusters
- Application of an harmonised M&E-System by x member states and IGAD for their external operations

### **Example Activities**

#### Output 1

- Elaboration of an appropriate structure and related *Standard Operating Procedures* (SOP) for implementing measures in cross-border natural resource management.
- Systematic collection and evaluation of experiences in managing cross-border natural resources (knowledge management, harmonized M&E system).
- Study on the effectiveness of IGAD Mechanism for Cross-border Cooperation & Borderlands Development, with emphasis on a preventive measures and structure-building approach.
- Preparation of an action plan for the dissemination of best practice in cross-border co-operation.
- Training for enhanced financial management;
- Preparation of ICT tools for internal training and information processing (e.g., atingi-E-learning platform, remote training).

#### Output 2

- Support to a cross-border steering committee (Kenya-Uganda) with the participation of local leaders.
- Develop selection criteria for pilot and model measures implemented in the border areas.
- Planning of cross-border measures for the sustainable use of water, livestock and pasture resources based on priorities identified by the *Transhumance Corridor Development Plan* and information provided by ICPAC and ICPALD.
- Implementation of pilot interventions along transnational migration routes.
- Introduce community managed disaster risk management.
- Facilitation of the development of local and regional agreements (by-laws) for using the water and rangeland resources along the main migration routes of pastoralists.

### **Example Activities**

#### Output 3

- Preparation of a legal framework for health data sharing and protection for adoption by IGAD member states.
- Activation of the tools for cross-border contact tracing in the SORMAS system.
- Elaboration of policy recommendations on pandemic response to be issued by the IGAD Secretariat to its member states, based on evidence-based results from SORMAS.
- Support & Strengthening Digital Health Capacities in the IGAD Member States for increased pandemic preparedness & pandemic resilience including COVID-19.
